and assigns, hereby I	RELEASE, WAIVE, DISCHARGE, INDEMNIFY AN	D HOLD HARMLESS the Hopkinson		
House Condominium	n Association, its' officers, directors, committe	e members, employees, managers,		
agents, heirs and assigns, (hereinafter referred to as RELEASEES) from any and all liability, claims,				
demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, illness,				
injury, including deat	th and/or drowning, that may be sustained by	me or the occupants of my/our		
unit/property, the po	ool facilities, or any of the property belonging	to me/us or the occupants of my/our		
unit/property, wheth	her caused by the negligence of the RELEASEE	S or otherwise while using and/or		
swimming in the swi	mming pool facilities and for anything in conn	ection with the activity or utilization		
of the swimming pool facilities.				

- 2. I/We am/are fully aware of the risks involved and hazards connected to the activity associated with the use of the swimming pool facilities including but not limited to the risk of property damage, personal injury, suffocation, drowning, and/or death. I/we hereby elect to voluntarily participate in the use of the swimming pool facilities on behalf of myself/ourselves and the occupants of my/our unit/property, WITH FULL KNOWLEDGE, UNDERSTANDING, AND ACKNOWLEDGEMENT THAT NO LIFEGUARD IS ON DUTY and that said activity may be hazardous to me/us and those participating. I/we HEREBY COVENANT NOT TO SUE RELEASEES, AND VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE, ILLNESS, OR PERSONAL INJURY that may be sustained by me/us, members of my/our family and/or the occupants of my/our unit/property, INCLUDING DEATH, drowning, suffocation or any loss or damage to property owned by the Association, as a result of being engaged or others being engaged in the activity relative to the use of the swimming pool facilities, and whether caused by the negligence of the RELEASEES or otherwise.
- 3. I/We further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss (including but not limited to monetary losses), liability, damage, or costs, including court costs and attorney fees, that they may incur due to the use of the swimming pool facilities by myself/us, members of my/our family and/or the occupants of my/our unit/property, whether caused by the negligence of the RELEASEES or otherwise.
- 4. It is my/our express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my/our family and/or occupants of my/our unit/property, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES. I/We hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the Commonwealth of Pennsylvania.

## 5. BY SIGNING THIS RELEASE, I/WE ACKNOWLEDGE AND REPRESENT THAT

I/we have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign voluntarily as my/our own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; and I/we execute this Release for full, adequate, and complete consideration fully intending to be bound by same.

- 6. I/we are solely and personally responsible for providing first aid for myself/ourselves/the occupants of my/our unit/property who utilize the swimming pool facilities as there is no lifeguard on duty.
- 7. In no way shall the use of the swimming pool facilities disturb the quiet enjoyment of the residents of the Hopkinson House Condominium Association.
- 8. The Association reserves the right to withdraw permission to use the swimming pool facilities if the foregoing conditions and covenants are not met or the Rules and Regulations are violated by us or the occupants of our unit/property.
